Tackling Chicken Pox vaccine Shortage By: Shaffin Jaafar & Michaelle Tan HP

Varicella zoster virus (VZV) causes two distinct clinical diseases. Varicella, more commonly called chicken pox is the primary infection which is normally benign and characterized by generalized exanthematous rash. Recurrence of the infection results in the more localized phenomenon known as herpes zoster, often known as shingles. Live attenuated varicella vaccine was licensed in the United States in 1995. It has been found to be highly effective against severe varicella (95%-100%) and less effective against mild disease (70%-90% in most studies). Most vaccinees who acquire varicella tend to have mild illness with fewer than 50 lesions compared to 250-500 lesions in unvaccinated persons. Immunity appears long-lasting. In one study, breakthrough of the disease in 10 years after one single dose was 7.3%. Most of it occurred in the first 5 years. In contrast, only 2.2% of children who received two doses had varicella. Hence the two-dose regimen is now recommended.

WHO should be vaccinated?

- A) all children at 12 through 15 months of age with a second dose usually at 4 through 6 years
- B) For susceptible persons aged 13 years or older who live in high risk areas for transmission (schools, child care, prisons, military, colleges)
- C) Non pregnant women of childbearing age
- D) Those who lives in household with children
- E) International travellers

Unfortunately, the Drug Control Authority (DCA) approved chicken pox vaccines in Malaysia -VARILRIX *, is facing a worldwide shortage. It has been out of stock for at least one and a half years now. The shortage can be traced back to GSK's production plant in Wavre, Belgium. GSK has stopped worldwide deliveries of the vaccines manufactured at the facility after discovering quality problems with some batches.

Due to the unmet needs, Merck (MSD) was asked to help to bring in VARIVAX ® to provide supply. As the product have not been registered and approved for use in Malaysia, hence it needs to be brought in under special import permit under the Pharmacy Legislation. As a temporary measure, Bahagian Perkhidmatan Farmasi KKM has given MSD a special permit that allows importation of VARIVAX ® to supply only to private hospitals and clinics.



MSD is currently doing the necessary to get VARIVAX ® approved for use in Malaysia. It hopes to get it approved by next year so that it will be readily available for purchase without having to go through the Import Permit hassle.

As for now, if there are any patients who needs the chicken pox vaccine urgently, you may write a prescription for your patient and refer them to call up the nearest Private hospital to check for stock levels.
